
11 **ORDER**

12 This case was tried to a jury on January 17, 18, 19, 23-27, 2006. The
 13 plaintiff was represented by Karen Lundahl and the defendant was represented by
 14 Grant Kinnear, Wes Edmonds of Gordon Edmonds, PLLC and Jean Jorgensen. A
 15 Special Verdict was entered on January 31, 2006 finding that Killebrew/Dalton, Inc.
 16 violated the Consumer Protection Act. After a full and complete trial the Court
 17 enters the following judgment:


- 18 1. That the plaintiff Latesha Gonzalez has judgment in her favor in the
 19 amount of \$2,000 plus treble damages of \$4,000, for a total amount of \$6,000.
 20 2. That Karen Lundahl, attorney for plaintiff shall have judgment in her favor
 21 for reasonable attorney fees in the amount of \$68,515.75 and costs of suit of
 22 \$2,376.86, for a total amount of \$70,892.61.
